## Frank Broeze Prize for Outstanding Doctoral Thesis in Maritime History

Professor Frank Broeze was one of the leading maritime historians of his generation. In his honour, the International Maritime Economic History Association has instituted the Frank Broeze Prize to be awarded to the author of a doctoral thesis which, in the opinion of the panel, makes the most outstanding contribution to the study of maritime history. As befitting Frank's visionary approach to the field, maritime history encompasses all aspects of the historical interaction of human societies and the sea. The panel of judges will therefore consider works that focus on the maritime dimensions of economic, social, cultural, political, technological and environmental history.

The Frank Broeze Prize carries with it a cash award of 500 Euros and free registration at the Seventh International Congress of Maritime History in Perth (Murdoch), Australia, 27 June-1 July 2016. To be considered for this prestigious award, those who have completed a doctoral thesis between 1 September 2011 and 31 August 2015 are invited to submit a copy of their thesis for consideration. If the thesis is written in a language other than English, the entrant should provide a summary of their work (minimum 10,000 words) in English.

The judges will apply the following criteria in deciding the winner of the prize:

- contribution to knowledge and understanding of the maritime past;
- originality of approach, source material and/or findings;
- depth and coherence of argument;
- choice and application of methodology;
- and presentational and stylistic quality.

Eligible candidates should submit their entries, including a letter of support from their supervisor, via e-mail attachment to each of the panel members no later than 30 January 2016. The winner will be notified during the spring of 2016, and the prize will be awarded at the Congress in Perth (Murdoch).

## Call for host: ICMH8 – 8<sup>th</sup> IMEHA Congress of Maritime History (2020)

The IMEHA (International Maritime Economic History Association) holds a Conference every four years which allows all of its members to share with the overall academic and non-academic community scientific and applied results in the field of maritime history, taken in its broadest sense encompassing all kind of relations that connect mankind with the sea. Political, economic, social, cultural and environmental history approaches are welcome, within a frame of interdisciplinary approaches running within a large scope of time (from Antiquity to the present) and space (micro, local, regional, global, world history).

The Conference was held on Corfu, Greece in 2004; Greenwich (UK) in 2008; Ghent (Belgium) in 2012 and will take place in Perth (Australia) in 2016. The Executive Board of IMEHA now launches an open call for proposals for the next Congress

(2020). The proposals will be presented to the General Assembly of the Conference in Perth, where a decision on the location of the 2020 conference will be made.

#### Who can apply?

- Academic and research institutions from all over the world that can guarantee compliance with the items listed below as selective pre-conditions.
  Submissions should be accompanied by an institutional statement of approval and commitment of the host institution.
- 2. Non-academic institutions, whose interests are connected with maritime research and have a track record of Conference organisations, preferably connected with research institutions. An institutional declaration of commitment is also required.

#### Academic standards

- 1. Discussion of cutting-edge topics on the field of Maritime History and its connections with other disciplinary fields.
- 2. High scientific standards offered by thematic panels organised by coordinators.
- 3. Submission of individual paper proposals organised into thematic panels under nominated coordinators.

#### **Requirements for the IMEHA Congress**

- 1. A conference of at least three and a half days, including a General Assembly of the Association, a session to distribute awards, a general round table and at least two key-note speeches.
- 2. A venue involving between 150 and 200 attendants coming from all over the world, mostly from Europe and North America.
- Adequate facilities able to accommodate, preferably in the same building, 3 to 5 simultaneous sessions.
- 4. Registration fees that should be consistent with the non-profit nature of the organisation.
- 5. Total organisation of the Conference, including all of the logistics and financial support and means.
- 6. Permanent liaison with the Executive Board of IMEHA.
- 7. Sound institutional background able to provide facilities, staff and funding.

- 8. Specialised and committed staff (including volunteers supporting the sessions).
- 9. Adequate scheduling, beginning at least two years in advance
- 10.Construction and access to the Conference webpage, including a remote platform of payment.

#### What should be provided by the Organising Institution

- 1. An organising committee and staff.
- 2. The payment of the travel and accommodation costs of at least two key-note speakers, one of which is potentially from overseas.
- 3. A welcome reception to all the Conference attendants
- 4. A Conference Dinner
- 5. Coffee breaks and lunches for the three days of the Conference and all the attendants
- 6. The dissemination of publicity about the Conference (networks, webpages, press releases, publicity in other Conferences etc.
- 7. Fellowships to post-graduate students to attend the Conference and/or exemption from the registration fee.

### **Preferential criteria**

- 1. A city of a medium range with an international airport (ground travel should be minimised for those coming from abroad).
- 2. A city with an historical and cultural heritage, preferably connected with the sea and maritime experiences.
- 3. Ample and diversified accommodation in terms of quality and prices.
- 4. High quality conference venue facilities
- 5. Experience with the organisation of large international Conferences

## The IMEHA Executive Board is expected to have a preferential vote on keyaspects:

- 1. The main subject of the Conference
- 2. The registration fee and its modalities (full payment; discount for associates; discount to students)
- 3. The key-speakers
- 4. The scientific board constitution

- 5. The wording of the call for papers
- 6. The scientific programme

In order to make this feasible, at least three members of the Executive Board must be on the organising and/or the scientific board

#### **Final remarks**

The Host Institution will commit to promote the IMEHA and its Journal, the IJMH, during the process of the Conference organisation.

The financial administration of the process is totally under the responsibility of the host institution. IMEHA should not be expected to input or receive any financial resources.

In 2016, DFDS celebrates the 150th anniversary of its foundation. The company is among the oldest and most famous European shipping lines. Over the years, DFDS has made a very substantial contribution to the economy and culture of Denmark, Britain and Northern Europe. Throughout its history, it has carried agricultural exports to the UK plus general cargo and passengers across a wide network of North European overnight routes. In addition, from the latter nineteenth onwards, DFDS was one of Denmark's pre-eminent international liner operators, its route network spanning from the Eastern Mediterranean to the Americas. During the 1960s, it became a pioneer of roll-on, roll-off shipping methods, bringing far greater efficiency to short-sea shipping and, in the early-1970s, it was among the first shipping companies to develop shore-based logistics operations with large fleets of trucks and associated infrastructure.

## Call for Papers: "Where Rivers Meet Oceans", Canadian Nautical Research Society Annual Conference and General Meeting

#### 18-20 August 2016

#### New Westminster, British Columbia

The mighty Fraser River, one of Western Canada's major waterways, winds from the Rocky Mountains down through treacherous gorges to the fertile plains of the Lower Mainland where it meets the sea at the Strait of Georgia near Vancouver. Renowned for its annual salmon run, natural habitat and present industrial and shipping uses, the river has fostered settlement and work for millennia, first with the Coast Salish peoples and later immigrants from around the world. New Westminster, the province's first capital and gateway for the Gold Rush, has a long association with the Fraser River. Once known as Canada's Liverpool for its port and terminals, the city has become a mature residential suburb with interesting cultural and heritage activities. A riverside promenade, commercial quay, steamboat museum and parklands welcome visitors.

Appropriately, the theme of the 2016 conference to be held in New Westminster is "Where Rivers Meet Oceans". Papers related to this theme, unimpeded by geography or time period, are invited, as well as any topic in maritime history of interest to a predominantly North American audience.

All individual paper proposals should include the name and affiliation of the presenter, a title, a 250 word abstract, and short bio or CV. Proposals for complete panels should include the same particulars as well as a proposed panel title.

Membership in the Canadian Nautical Research Society is encouraged, though not required. All presenters will have to pay their own conference registration fee. Should presenters wish to publish their paper for a larger audience, the society's peer-reviewed academic journal The Northern Mariner/Le marin du nord is available. <u>http://www.cnrs-scrn.org/northern\_mariner/</u>

The study of port cities and their relationship to maritime endeavour and enterprise is a diverse and interdisciplinary practice, which draws on research methods from sociology, anthropology and archaeology, and brings together aspects of social, economic and cultural history. In April 2016, the Centre for Port and Maritime History will hold its first postgraduate conference at the University of Strathclyde.

The aim of this two-day conference is to bring together postgraduates and early career researchers working on any aspect of port or maritime history across a wide range of chronologies and geographical settings. We hope that this event will encourage postgraduate students to become involved in the recently founded International Postgraduate Port and Maritime History Network. As this network is international, we particularly invite proposals from researchers working at institutions outside of the UK.

Possible themes, are not limited to, but may include:

- Urban culture in port towns and cities
- The economics of trade and commerce by sea
- The social and economic impact of naval warfare

- International and transnational networks
- Crime and deviancy at sea and on shore
- Shipbuilding, navigation and maritime instruments
