The Congress will be hosted by Murdoch University, the Western Australian Maritime Museum, the Australian Association for Maritime History and the International Commission for Maritime History and held at Murdoch University, Perth Australia.

The theme for the conference is "Old Worlds, New Worlds? Emerging themes in maritime history". ICMH7 has adopted a broad concept of maritime history, considering all interdisciplinary fields, covering all historical periods and various aspects of humankind's relationship with the sea from ancient times to the present.

# New book: How and why the Dutch fished for cod 1818-1911

Christine Rosenørn Overgaard tells the story in English of how and why the Dutch fished for cod from 1818-1911. Cod fishing was a hook and line fishery. During the 1800s, new vessels and new gear was introduced, especially trawling along the coast in winter in late 1800s. By looking at sources not yet applied in Dutch fishing history she shows how several fishermen fishing for cod ignored these initiatives not because of lack of entrepreneurial spirit, but because of concern for the environment and the cod stock. She examines the business structure in fishing: family business with shared ownership and limited company, including sources showing the importance of social network among ship owners and fishermen. She places cod fishing business within an institutional analysis and development framework, which on the one hand emphasizes the rules the fishermen set for themselves on how, when and where to fish for cod, and on the other hand sees cod fishing as one of several businesses in Dutch (inter)national politics. She illustrates the consequential dilemma facing the ship owners and fishermen when deciding on

a profitable or a sustainable business, providing an alternative theory on growth in business, indicating new approaches to current cod fishing.

**Crews and Dockers** 

Organizers: Enric Garcia (Universitat de Barcelona) and Jordi Ibarz (Universitat de Barcelona)

Maritime industries may have different faces, but all of them have at least one point in common: cargo. Everything is linked to it: ships, ports and infrastructures, institutions, companies, etc., and obviously those who handle the cargo, on board and ashore. Our aim is to analyze the labour relations that make maritime economies possible, focusing on the relationship between two collectives: seamen and dockers. We call for papers on labour relations, contract and payment methods, labour conditions, professional categories, skills, professional qualification and deskilling processes, hierarchy and discipline, guilds and trade unions, training, the making of seamen and dockers as a working group, relationship between both groups, the impact of globalization in the shipping industry on this professional groups, etc. We propose a cross-period approach to seamen and longshoremen, up to the latest transformations undergone in the maritime economies after containerization.

There is an extensive bibliography on maritime labour. However, despite significant efforts by historians, some peripheral areas have been neglected. Any contribution will be welcome, but especially those focused on the Mediterranean Europe and, in general, on the Global South.

The ELHN Working Group on Maritime Labour History invites you to participate in this conference in order to present and to share the results of your ongoing research, and also as an opportunity to meet other colleagues working in the same field.

# **Invitation: Join Working Group on Maritime Labour History**

European Labour History Network – ELHN Working Group on Maritime Labour History

The founding meeting of the European Labour History Network (ELHN) took place at the International Institute of Social History (IISH) on 12 October 2013. The scholars who gathered in Amsterdam felt the need to increase the cooperation among labour history scholars, share knowledge and (digital) material, create a platform for future collective research, and organize conferences and seminars. The Network will primarily include Europe-based scholars (professors, post-doc and PhD researchers, post-graduate or students), but will also seek to connect with scholars based outside Europe.

In the last twenty years Maritime History has experienced an innovative development, but, as a matter of fact, work and workers had been usually neglected. Few areas (i.e. docks and dockers) had received full attention from

scholars. In addition, although a number of scholars and specialist do research on this field, there is a lack of coordination between them and, moreover, between researchers in each area. Thus, merchant shipping or fisheries are studied commonly as a separate body disconnected from the rest of the maritime sectors. We propose to look ashore and offshore with a broad view

On the other hand, maritime economies are essentially international, and so are some of the labour characteristics. Maritime industries had, in turn, a strategic role in the national economies and in national defense as well through different instrument of register, conscription and enlistment. Thus, maritime labour has developed singular features over ages. Maritime labour history should be studied and analyzed in order to incorporate it to the rest of literature on labour history.

Maritime industries can be divided in four broad areas, linked between them and whose frontiers are sometimes unclear and should be viewed as a whole: Merchant marine (coastal and ocean going navigation, shipping industry, etc.); Fishing industries (coastal and deep sea fishing, tuna traps, whaling, canning industries, etc.); Shipbuilding and ship repair industries; and cargo loading and unloading.

The history of maritime labour includes a number of topics that can be discussed: labour relations, contract and payment methods, labour conditions, professional categories, skills, qualification and decualification processes, health and safety, welfare, intervention of the State, hierarchy and discipline, guilds and trade unions, permeability between sectors, identities, etc. From a European approach, comparative studies are needed and should be encouraged.

The ELHN Working Group on Maritime Labour History has different goals. We want to promote cross-period research in this field. We also intend to inform the research community about ongoing research, resources, workshops and conferences. Furthermore, we aim to exchange information and knowledge between scholars devoted to this area. Finally, we will promote joint projects, seminars and other form of meetings.

# New book: International seafarers and transnationalism in the twenty-first century

By Helen Sampson

**Publisher: Manchester University Press** 

Winner, 2014 BBC Radio 4's Thinking Allowed inaugural award for ethnography, in association with the British Sociological Association.

This ethnographic account of seafarers considers issues of transnationalism in the twenty-first century and discusses the detailed life experiences of migrant workers in this context. It argues for a consideration of the social space available to

transnational migrant workers and suggests that the transnational experiences of migrants may be more likely to involve exclusion and alienation than an expansion of social space as a result of bi-location in more than one community.

Based upon original qualitative research in three different settings, the book, now available in paperback, draws upon voyages undertaken by the author on five different working cargo ships. It describes the situation of seafarers from Cape Verde and Ghana searching for work in northern Germany and considers the perspectives of women married to Indian seafarers resident in Goa and Mumbai.

This highly readable book will be of interest to readers from a variety of disciplines who are interested in ethnography, particularly in the fields of social sciences and humanities who are interested in issues of migration, transnationalism, work, the shipping industry and globalisation. It will also appeal to individuals with a connection to, or an interest in, the merchant navy.
